## **Announcement on Completion of Reduction Scheme on Shares held by Part of Top Management**

This Company and all members of the Board of Directors hereby warrant that all information disclosed here are true, accurate and complete, and contain no fictitious statement, misleading information or significant omission.

Zhejiang Supor Co., Ltd. (hereinafter referred to as “the Company”, “this Company” or “Supor”) received the Notification on Completion of Reduction Scheme on Shares issued by CFO Mr. Xu Bo who had completed Reduction Scheme on Shares. The relevant information is announced as follows:

### **I. Introduction on Reduction Scheme Disclosure of Top Management**

The Announcement on Pre-disclosure of Reduction Scheme on Shares held by Part of Top Management was disclosed on April 19<sup>th</sup>, 2019, announcing that CFO Mr. Xu Bo planned to reduce his shares by the means of concentrated bidding or block trade within 6 months starting at May 15<sup>th</sup>, 2019 (excluding blocked time slot). The total number of shares to be reduced this time would not exceed 102,900, amounting to 0.013% of total capital stock of the Company.
